As a CxA, you will fill an essential role in our growing business by supporting commissioning and design work. Your primary responsibilities would include MEP installation verification, functional test plan writing and execution, commissioning witness testing, commissioning plan writing, coordination and plan execution and energy analysis services for both new and retrofit projects for a variety of facility types within the private, public and municipal sectors including but not limited to commercial, institutional, healthcare, and educational facilities.

You are responsible for managing project budgets for multiple projects simultaneously. In this role, you provide leadership for projects and provide support to staff as well as field oversight of construction and commissioning activities.

Using your strong troubleshooting and problem-solving skills, you will evaluate systems/components for function and reliability. You will oversee MEP installation verification, functional test plan writing and execution.
